# Financial Regulations for the ANSO Projects (2024 revision)

## **Chapter I General Provisions**

**Article 1** These regulations apply to collaborative research, international conferences and other projects jointly planned and implemented by members and partners of the Alliance of National and International Science Organizations for the Belt and Road Regions (hereinafter referred to as ANSO) and other international organizations or institutions.

**Article 2** The Proponent's Affiliation and the Principal Investigator, as well as all collaborating units listed in the proposal shall follow these regulations.

**Article 3** The Principal Investigator shall follow these regulations when preparing the project budget plan, submitting the annual financial report and the final financial report to the ANSO Secretariat.

# Chapter II Responsibilities of Proponent's Affiliation and Principal Investigator

**Article 4** Responsibilities of the Proponent's Affiliation: strengthen corporate responsibility and ensure the reasonable and standardized use of funds; compile and submit the project budget accurately, use the funds strictly according to the budget, manage, supervise and inspect the funds during project implementation; strictly implement the financial regulations and accept the supervision and inspection by the third-party institutions and expert panels appointed by ANSO.

**Article 5** The Principal Investigator is the person who bears direct responsibility for the authenticity, compliance and relevance of the fund usage.

**Article 6** The Principal Investigator shall maximize the use of existing resources, such as employed staff, existing office or meeting venues and equipment, to formulate joint funding plans scientifically.

#### **Chapter III Scope and Rules of Expenditure**

Article 7 The scope of expenditure includes: equipment fees, remuneration, business expenditure and other expenses.

**Article 8** Equipment fees (non-procurement): refer to the necessary costs incurred during project implementation for upgrading existing instruments and equipment which specially used for ANSO project, as well as for short-term rental of external equipment, not exceeding 5% of the total budget, and not to be used for fixed assets or intangible assets procurement.

**Article 9** Remuneration: refers to the labor costs paid during project implementation to project participants such as graduate students, visiting personnel, postdoctoral researchers, visiting scholars and scientific research assistants, and fees paid to temporarily hired consulting experts. Such fees shall not be paid to personnel involved in the research and management of the project.

 (i) Expert consultation fees shall be based on experts' professional titles and take into account the remuneration standards of their country, organization or institution. In principle, the expert consultation fee of full professor shall not exceed USD300/person/day (after tax), and for associate professor or below, the payment shall not exceed USD200/person/day (after tax). Unless working hours reach 6 hours or more, it shall not be considered a full day.

- (ii) If temporary research assistants are needed during project implementation, their employment should be part-time. Part-time remuneration shall be paid based on the tasks and hours of work undertaken in the project, and considering the remuneration standards of part-time positions in their respective countries, organizations or institutions. ANSO funds shall not be used for fulltime employment.
- (iii) The standard of lecture fee for instructors in training courses shall be subject to the above expert consultation fees. The cost of temporarily-hired training assistants shall be determined reasonably based on the tasks and hours of work undertaken in the project.
- (iv) The budgeted amount for remuneration in the project shall not exceed 20% of the total funds.

Article 10 Business expenditure: refer to the costs incurred during project implementation for the purchase, transportation, loading/unloading and organization of various materials, auxiliary materials, low-value consumables, health and safety protective equipment directly related to scientific experiments. Such fees also include expenses related to testing, analysis, processing, fuel and power, publication/literature/information dissemination/intellectual property affairs, travel/meetings/international cooperation and exchanges, etc.

- (i) **Travel expenses:** the travel expenses for ANSO's projects include the costs incurred by the Principal Investigator, collaborators and other relevant personnel for conducting project activities. The travel expenses shall be reimbursed based on actual expenses within the standard, and shall be disclosed in detail in the financial report.
  - 1. When traveling by plane, economy class tickets shall be purchased in principle, and any upgrade fees shall not be reimbursed;
  - 2. ANSO funds can cover necessary expenses such as airport taxes, visa fees, vaccination fees, basic travel insurance, conference registration fees, etc.;
  - 3. When traveling by train or ship for project activities, economy class tickets shall be purchased;
  - 4. The costs for round-trip transportation from remote airports, terminals or train stations to hotels can be reimbursed;
  - 5. When renting cars for scientific research activities, the rental expenses shall be reimbursed within the specified limit based on actual expenses. The reimbursement amount shall not exceed USD120/person/day, which includes car rental fees, fuel costs, insurance fees, tolls/highway fees and parking fees;
  - 6. Accommodation fees and subsistence allowances refer to the

costs incurred for accommodation and daily subsistence allowance during business trips.

 Funds shall only be used to pay expenses directly related to project activities;

(2) Accommodation expenses shall be reimbursed based on actual expenses within the specified limit. The daily accommodation expense shall not exceed either the accommodation standard set by the Proponent's Affiliation or that of ANSO (refer to Annex 1);

(3) Accommodation expenses may include breakfast but shall not be used to pay for other expenses;

(4) Daily subsistence allowance includes food allowances and local transportation subsidies. If the conference organizer covers food and local transportation expenses, attendees shall not claim daily subsistence allowance.

(5) The daily subsistence allowance shall not exceed either the standard set by the Proponent's Affiliation or that of ANSO (refer to Annex 1). The calculation of the number of days for claiming such expenses shall be based on the dates specified in the traffic tickets.

 (ii) Conference expenses: conference expenses refer to the total costs incurred due to organizing conferences for academic discussions and experience exchange. These expenses include venue or equipment rental fees, accommodation fees, meal fees, refreshment fees, material fees, transportation costs and other related expenses.

For the standards of conference accommodation and meals shall not exceed either the standard set by the Proponent's Affiliation or that of ANSO (refer to Annex 1). Expenses for alcoholic beverages and meals unrelated to the conference shall not be reimbursed.

Miscellaneous expenses necessary for each conference, such as office supplies, document printing and video conferencing platform fees, shall not exceed USD20/person/day.

- (iii) Material expenses: refer to the costs of purchasing, transportation, loading/unloading, and organization of various raw materials, auxiliary materials and low-value consumables consumed during the project implementation. For any type of material with a total material budget reaching USD 20,000 (inclusive) or more, a detailed explanation shall be provided regarding its relevance to the project tasks, the necessity of the purchase, and the reasonableness of the quantity.
- (iv) Testing, laboratory processing and fuel power costs: Testing and laboratory processing costs refer to expenses incurred for necessary inspection, testing, design, chemical examination, processing or data purchase during project implementation. These costs typically include the analysis, detection, experiments and related processing of samples. Fuel power costs refer to separately measurable expenses for water, electricity, gas and fuel consumed

by large instruments, specialized scientific devices and other equipment during project implementation.

(v) Publication, dissemination, intellectual property affairs and other business expenses: refer to the publication fees, documentation fees, literature search fees, professional network and communication fees, patent and other intellectual property application and maintenance fees, etc. that need to be paid during the project implementation.

The total cost of material expenses, testing and laboratory processing costs shall not exceed 30% of the total annual budget, and shall be reported to the ANSO Secretariat for approval in exceptional circumstances.

Article 11 Other expenses: refer to expenses incurred during project implementation other than the aforementioned costs, including daily consumption of water, electricity and heating, subsidies for relevant management expenses, necessary remittance charges, and audit fees. A small amount of administrative expenses may be drawn from the ANSO project funds, but it must not exceed 5% of the total project funds.

**Article 12** In the process of budget implementation, the adjustment of business expenditure and remuneration shall be independently arranged by the Principal Investigator according to the actual needs of the project. The budget of equipment and other expenses shall not be increased, and may be reduced for business expenditure and remuneration after

consultation between the Principal Investigator and the Proponent's Affiliation.

#### **Chapter IV Funding Allocation Requirements**

**Article 13** ANSO funds shall be used exclusively for their specified purposes and accounted for independently. The Principal Investigator and the affiliated institution are not permitted to arbitrarily split the ANSO project into topics.

**Article 14** After receiving the annual project funds, the Proponent's Affiliation (leading unit) shall promptly allocate the funds to the collaborating units according to the budget. Funds shall not be allocated to collaborating units within China (excluding the procurement of materials or services within China).

- After receiving the funds, the collaborating units shall not reallocate the funds to other entities;
- (ii) The Proponent's Affiliation and collaborating units shall not outsource scientific research tasks through technical service contracts;
- (iii) After allocating funds to the collaborating units, the Proponent's Affiliation shall be responsible for supervision, inspection, and the completion of annual reports to ensure that all expenditures do not exceed the specified standards.
- (iv) The Co-funding Research Project funds undertaken by the CAS institutions will be directly allocated by the ANSO Secretariat.

**Article 15** For Co-funding Research Projects, the co-funding parties who provide support in the form of funds, sites, channels or resources shall provide relevant supporting materials within a reasonable timeframe.

If there is no substantial progress in the project within a reasonable period after the Proponent's Affiliation has received the funds, the project funds shall be returned to the ANSO Secretariat in a given time.

## **Chapter V Remittance and Vouchers**

**Article 16** The Proponent's Affiliation of ANSO projects shall provide a letter confirming their ability to receive international remittances in USD or RMB.

**Article 17** The Principal Investigator shall provide accurate and complete account information confirmed by the finance department of its institution, as well as any other necessary information required for bank payments.

Article 18 The Principal Investigator shall provide the invoice (see Annex 2) to the ANSO Secretariat.

#### **Chapter VI Financial Report**

**Article 19** After the end of the project year, the Principal Investigator shall submit the annual financial report to the Secretariat within one month of receiving the notification. At the conclusion of the project, the Principal Investigator shall submit both the project summary report and the financial report to the Secretariat.

Article 20 The annual financial report submitted to the ANSO

Secretariat shall include:

- (i) Detailed expenditure account;
- (ii) Financial report jointly signed by the Principal Investigator, the head of financial department and the legal representative of the Proponent's Affiliation.

**Article 21** At the conclusion of the project, the Proponent's Affiliation shall engage a local qualified accounting firm or similar institution to audit the final financial report and issue an audit report. The audit report and the audited financial report shall be submitted to the ANSO Secretariat. The project-related original vouchers shall be properly archived by the Proponent's Affiliation and retained for at least five years from the date of project conclusion acceptance. The ANSO Secretariat reserves the right to conduct further audits.

## **Chapter VII Management of Surplus Funds**

Article 22 If there are any surplus funds during each year of project implementation (excluding the final year), a clear explanation shall be provided in the annual financial report. In principle, these surplus funds should be used to offset the budget for the next year. In special circumstances, the Principal Investigator may submit an application, and upon approval by the ANSO Secretariat, the surplus funds can be carried over to the next year for use without offsetting the budget for the next year.

Article 23 Upon successfully achieving project objectives and passing the final acceptance, any surplus funds are retained by the Proponent's

Affiliation for use, and the final project payment is granted. If project objectives are not completed or if the final acceptance is not passed, the final project payment will not be granted.

**Chapter VIII Fund Management, Supervision and Inspection Article 24** The legal representative (or authorized person) of the Proponent's Affiliation and the Principal Investigator shall jointly sign a commitment letter during budget preparation, which aims to ensure the authenticity of the information provided and hold them responsible for any consequences resulting from false information.

Article 25 The Proponent's Affiliation shall strictly adhere to the expenditure scope and standards specified in these regulations.

(i) It is prohibited to use falsified invoices to withdraw funds;

(ii) It is prohibited to falsify labor contracts, fabricate lists of personnel, or engage in other forms of misrepresentation to fraudulently claim remuneration and expert consultation fees.Consulting service fees must not be paid through outsourcing under technical contracts;

(iii) ANSO project funds shall not be used to substitute or supplement the salary of the Principal Investigator, nor shall they be used for the indirect salary of administrative personnel;

(iv) ANSO project funds shall not be used to pay for any form of tokens, gifts or souvenirs;

(v) ANSO project funds shall not be used in any way to cover any expenses that should be paid personally by individuals or to pay

fines, donations, sponsorships, investments, etc. It is strictly prohibited to seek personal gain through any means;

(vi) ANSO project funds shall not be used to cover any expenses arising from activities unrelated to the project.

**Article 26** The ANSO Secretariat has the right to commission any third-party institutions or expert panels to supervise and inspect the budget execution and fund utilization of the project.

**Article 27** For Proponent's Affiliations that fail to use the project funds as required during budget execution, the ANSO Secretariat shall have the right to suspend fund disbursement and issue a notification. In severe cases, the project may be terminated.

**Article 28** For violations such as failing to complete acceptance work on time, failing to pass financial acceptance, engaging in falsification, or maliciously misappropriating project funds, the ANSO Secretariat will suspend the acceptance of applications from the Proponent's Affiliation or the Principal Investigator for ANSO projects.

#### **Chapter IX Supplementary Provisions**

**Article 29** These regulations will be implemented from the date of revision, and the original "Financial Regulations for the ANSO Projects (2022, Provisional Version, By ANSO Secretariat)" will be simultaneously repealed.

**Article 30** For projects that are still ongoing at the time of publication of these regulations, or projects whose execution period has ended but final acceptance has not yet been conducted, these regulations may be

referred to.

Article 31 The ANSO Secretariat is responsible for the interpretation of these regulations.
